



- Booksy International (Instead of regular sale of shares in Polish company, we participated in a conversion of its shares into stock in US based company belonging to Booksy Group. Those shares were later sold to external investors, allowing for particular gain; by selling share in the US, more recognisable Affiliate, our client was able to get much better price then by selling shares in the Polish Booksy company, which are not so attractive worldwide).
- Kiwi Jobs (spin-off of a special purpose vehicle active in the e-recruitment market and its sale to OLX Group).
- Brand New Galaxy (we supported our client in succesful exit from one of the most renown marketing agencies on Polish market)

MBIs (Management Buy-Ins)

We supported a key manager in his investment in Car Scanner.

We supported a private investor in the process of buy in and take over of managerial position in the world's first mobile vehicle condition tester that uses robotics and Al solutions to help sell used cars. The investment took place in Canada, US and Poland.

MBOs (Management Buy-Outs)

Acquisition of majority stake in Norlys, world renown outdoor lighting producer

We participated in an acquisition of an international manufacturer and distributor of outdoor lighting in the form of MBO. As part of the transaction, we represented Norlys's key shareholder and the new president of the group in negotiations with the remaining shareholders and the private equity fund Avallon MBO (which became a strategic shareholder of the group).


